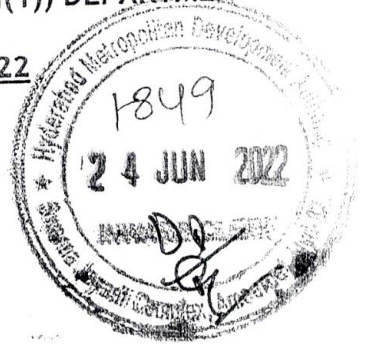

The attention of the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority is invited to the references cited. In the reference 2nd cited one Smt. G.Madhuri has represented the Government that in G.O.Ms.No.403 MA dt:02.08.2006 Govt., have issued orders for changing the land use of her site in Sy.Nos.332/P, 354/P & 355/P of Medchal (V) & (M), Medchal-Malkajgiri (Dist) to an extent of 5109.68 Sqmts., from Recreational use Zone to Residential use and same was carried out in HMDA Master Plan-2021 approved in G.O.Ms.No.288, MA, dt:3.4.2008. But in subsequent Master Plan-2031 approved in G.O.Ms.No.33, MA, dt:24.01.2013 same was not carried out and her land has again earmarked for Recreational use. In this regard she has requested the Govt., to consider the land use as Residential use in view of G.O.Ms.No.403, MA, dt:02.08.2006 and Master Plan-2021.
